What is the Yamoussoukro Declaration?

Which countries have ratified the Yamoussoukro Decision?

According to the World Bank, the Yamoussoukro Decision has been signed and ratified by all members of the AU except Djibouti, Equatorial Guinea, Eritrea, Eswatini, Gabon, Madagascar, Mauritania, Morocco, Somalia and South Africa.
